# Helpful tips and instructions on what to do.

### **1** Your Mortgage document contains multiple pages.

### Only complete the 'Mortgagor Execution' section.

- Follow the notes and steps below.

### A The witness needs to:

- Not be a party to the loan or the transfer of the property
- Write their full name (no initials)
- Have a consistent signature in all documents signed
- Write their full address (No PO Box)
- Be a person over 18 years of age

Mortgagors should NOT witness each other

### **B** Who's the mortgagor?

The mortgagor is the owner/s of the property which the mortgage is being taken over. This property is providing the security for the loan.

Inconsistencies in signatures may result in delays to your home loan.

### Make sure to add the date.

This is a sample of a mortgage with **1 mortgagors**. The Mortgagor Execution may appear on page 1 or 2

- Sign and date **both copies of your mortgage**
- Only use a **black pen**
- If you make a mistake, please don't try to fix it contact your Lender or Broker for help.
- If your mortgage needs to be witnessed overseas, please turn over this page for further instructions.

### Completing the form if Overseas:

#### Step 1.

Determine who will be witnessing your loan documents:

### Form A

If a Consular Officer – utilise the "Australian Embassy/High Commission/ Consulate Identity/ Witnessing Certification".

### Form B

If another Acceptable Witnesses Notary Public, Competent Officer, Australian Lawyer or New Zealand Lawyer" utilise the "Identity Witnessing Certification.

Please speak to your Lender/Broker for the relevant forms or they are available from the Bankwest Website.

### Step 2.

Take the forms and documents with you (where necessary) to have your mortgage documents and identification verified. An appointment may be required.

#### Step 3.

The witness will complete the form and provide certified copies of the identification documents in support of your application, which you will need to return along with the mortgage documents.

Please contact your Lender/Broker if you are unsure of the valid photographic identification requirements.
