

Bankwest Kiosk Promotion Perth Home Show Bunnings Gift Card Competition

Terms and conditions

- 1. This competition commences at 10am on Friday 21st June 2024 and closes at 5pm on Sunday 23rd June 2024 ('Promotional Period'). Taking part in this competition constitutes acceptance of these terms and conditions.
- Bankwest, a division of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL/Australian credit licence 234945, Bankwest Place, 300 Murray St, Perth WA 6000, ph. 13 17 19, is the promoter of this competition authorised under the promotion governed by the laws of Western Australia and each entrant agrees to submit to the non-exclusive jurisdiction of Western Australia.
- 3. Entry is open to Australian residents ('Eligible Entrants') who:
 - a. Reside in Western Australia and
